Thinking of making an addition, improvement, or change on your property?

As the summer project season begins, please remember that most property improvements require approval from the Architectural Review Committee (ARC). Repainting, replacing windows, building a fence, replacing a driveway, or installing a shed/playhouse are all examples of projects that need to be reviewed. Please submit your project details in advance of starting your project,

ideally 30 days. You can do this online by going to https://www.terragrandeca.com/architecture-review-forms and submit your proposed project for review. If you are unsure whether your project needs approval, please contact a member of the ARC.

As defined in Sections 4, 5, 6, 7, 8, and 13 of the "TGCA Community Information and Policy Manual", prior to starting ANY change to a lot within Terra Grande, the homeowner shall provide the required documentation to the Terra Grande Architectural Review Committee.

Selling Your Home?

The Virginia Property Owners' Association
Act requires that the seller provide a
disclosure packet to the purchaser before the
sale is final. The disclosure packet
requirement applies to all types of sales
whether handled by the owner or a realtor.
To obtain a disclosure packet for your home,
go to the TGCA website and under "Forms"
select the "disclosure packet request" at least
two weeks ahead of when you will need it
completed.

New to the Neighborhood or Moving Back?

The disclosure packet you received from the seller included a TGCA directory form ("item 06 – TGCA Directory Form" is the filename in the packet.) Please fill out this form and send it in as soon as possible so we can update our records with your information.

Soccer Field Reservations for your Summer Event

If you are planning on having a gathering or an event and would like to reserve the soccer field, please go to

https://www.terragrandeca.com/athletic-field-request-form and submit your request. As a reminder, bounce houses, climbing walls, or other similar play structures are NOT allowed at the soccer field or anywhere else on common property within Terra Grande due to insurance restrictions. If you are planning an event and would like to have a bounce house (or similar play structure), you will need to host the event on your own property. If you have any questions, please contact a board member.

More TGCA Board Members are Needed!

Many of our board members have been on the board a long time, and some are moving on. We are in need of help to maintain our volunteer board, which is why our association fees are so low for this area. Please consider becoming a board member and helping with our community! Home Maintenance and Community Canvas

All Terra Grande neighborhood residents – <u>owners and renters</u> - need to follow the rules in the "TGCA Community Information and Policy Manual", which owners received when they purchased their home. It is also available at the Terra Grande Website, <u>www.terragrandeca.com</u>. Once there, click on "Resources", then click on "Terra Grande Policy Manual".

Members of the TGCA Board will be touring the Community monthly and notifying homeowners of any violations of our policies regarding the maintenance of your property. Items we will be looking at include trash cans not hidden from street view on non-trash days, sidewalks blocked by bushes or plants, junk cars (see homeowner's manual for definition) in driveways and in front of houses, doors and windows in disrepair, mold growing on the front or sides of the home, cracks in driveways, items being stored in view from the street etc. If you have any questions about this, please contact any member of the Board.

Please remember to trim bushes and plants that block the sidewalk!



With all the rain this spring, plants are growing fast! Please remember to trim your bushes, trees overhanging low over the sidewalk, and other plants so they are not blocking any of the sidewalk. Many neighbors walk the neighborhood and need access to the sidewalk.

Please remember to keep your lawn mowed!

The Terra Grande Policy Manual states that the grass may not be taller than nine (9) inches.
