Common Property

Every effort is made to maintain and address concerns with regards to common property in the Terra Grande Community. We are thankful for all that have participated this year in achieving the following:

- a) Addition of new signs at the soccer field, tennis court, and playground areas.
- b) Addition of new basketball hoops and nets at the Chillum Court.
- c) Addition of new soccer goal nets.
- d) Repair and painting benches at both playground areas.
- e) Continued repair and replacement of rails and post along Terra Grande Ave.
- f) Renewal of the landscaping and mowing contract for the next few years.
- q) Removal of just over 10 trees from the common property that concerned home owners.

For any issues or concerns with common property, please contact Rex Lovelady, 703-309-7227. It is through community and individual efforts that we are able to keep Terra Grande Community a pleasant place to live.

Thinking of making an addition, improvement, or change on your property?

Please remember that most property improvements require approval from the Architectural Review Committee (ARC). Repainting, replacing windows, building a fence, replacing a driveway, or installing a shed/playhouse are all examples of projects that need to be reviewed. Please submit your project details in advance of starting your project, ideally 30 days. You can do this online by going to https://www.terragrandeca.com/architecture-review-forms and submit your proposed project for review. If you are unsure whether your project needs approval, please contact a member of the ARC.

As defined in Sections 4, 5, 6, 7, 8, and 13 of the "TGCA Community Information and Policy Manual", prior to starting ANY change to a lot within Terra Grande, the homeowner shall provide the required documentation to the Terra Grande Architectural Review Committee.

Home Maintenance and Community Canvas

All Terra Grande neighborhood residents – <u>owners and renters</u> - need to follow the rules in the "TGCA Community Information and Policy Manual", which owners received when they purchased their home. It is also available at the Terra Grande Website, <u>www.terragrandeca.com</u>. Once there, click on "Resources", then click on "Terra Grande Policy Manual".

Members of the TGCA Board will be touring the Community monthly and notifying homeowners of any violations of our policies regarding the maintenance of your property. Items we will be looking at include trash cans not hidden from street view on non-trash days, sidewalks blocked by bushes or plants, junk cars (see homeowner's manual for definition) in driveways and in front of houses, doors and windows in disrepair, algae and/or mold growing on the front or sides of the home, cracks in driveways, items being stored in view from the street etc. If you have any questions about this, please contact any member of the Board.

Selling Your Home?

The Virginia Property Owners'

Association Act requires that the seller provide a disclosure packet to the purchaser before the sale is final. The disclosure packet requirement applies to all types of sales whether handled by the owner or a realtor. To obtain a disclosure packet for your home, go to the TGCA website and under "Forms" select the "disclosure packet request" at least two weeks ahead of when you will need it completed.

<u>Dog Walkers - Please be</u> <u>considerate of your</u> neighbors!

Please do not leave your bagged dog feces in your neighbor's yard waste bins. Plastic bags are not accepted in yard waste. Also, please don't leave them in your neighbor's trash cans or in their yards either.

Soccer Field Reservations for an Event

If you are planning on having a gathering or an event and would like to reserve the soccer field, please go to https://www.terragrandeca.com/athletic-field-request-form and submit your request. As a reminder, bounce houses, climbing walls, or other similar play structures are NOT allowed at the soccer field or anywhere else on common property within Terra Grande due to insurance restrictions. If you are planning an event and would like to have a bounce house (or similar play structure), you will need to host the event on your own property. Porta-pottys are not allowed at any Terra Grande common property. Please remember that all trash from your event should be removed at the end of the event and not left in the community trash cans.

Please remember to trim bushes and plants that block the sidewalk!



Please remember to trim your bushes, trees overhanging low over the sidewalk, and other plants so they are not blocking any of the sidewalks. Many neighbors walk the neighborhood and need access to the sidewalk.
